Sam's Kamp K-9, LLC is committed to the ultimate in quality care for your pampered pup. Now, you can relax and get away, knowing your kamper is receiving all of the love, care and attention it would receive at home.

The services we provide are done so without liability for loss or damage from disease, death, running away, theft or fire, and from injury or damage done by your kamper to people, other animals or property, or other unavoidable causes. We have a dedicated, loyal, energetic staff who are highly trained in the care of animals and are also pet owners and lovers. Due diligence and care has been exercised.

Should any kamper become ill or need medical attention, we reserve the right to administer aid and to render care by your local designated veterinarian, if available, or by a veterinarian of our choice. Any expenses incurred, being reasonable in amount, shall be paid promptly by the owner. There is a \$35.00 transportation charge to the Vet's office.

No kamper will be released until all charges are paid in full or other arrangements satisfactory to our establishment have been made. The customer agrees to 24 hours notice if there is any change in the kamper's pick-up date, otherwise owner will be charged for the original previous confirmed departure date.

The owner of this kamper or his agent agrees to pay reasonable legal fees and costs incurred by our establishment in the collection of outstanding bills.

Owner agrees to place identification on all belongings left with kamper. Our establishment is not responsible for the loss or damage of kamper's personal belongings.

All kampers over 7 months of age should be spayed or neutered. Males that are not neutered must not show any form of aggression. Females that are unaltered: We have permission to transport kamper to kamper's regular veterinarian for boarding in the event the kamper comes "in season" and the owner has made prior arrangements with kamper's veterinarian. There is a \$35.00 transportation charge.

If my kamper arrives with fleas/ticks or is odorous/dirty, I authorize Sam's Kamp K-9, LLC to give my kamper a flea bath. There is a \$30 charge.

ALL KAMPERS DROPPED OFF OR PICKED UP BEFORE OR AFTER BUSINESS HOURS WILL BE CHARGED A SURCHARGE OF \$25.00.

WE ACCEPT CASH OR CHECKS ONLY-SORRY, FOR THE INCONVIENCE-THERE IS A \$35.00 NSF CHARGE FOR ALL RETURNED CHECKS

EMERGENCY CONTACT MUST BE AVAILABLE TO PICK UP KAMPER(S) IMMEDIATELEY IN CASE OF EVACUATION or EMERGENCY.
